ABOUT THE WEBSITE

- 3. Healthii Hub reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Healthii Hub updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue we recommend you keep a copy of the Terms for your records

ACCEPTANCE OF THE TERMS

- 2. Healthii Package and Healthii Premium Packages accounts are currently offered. You acknowledge and agree that the accounts offered, as well as the account features may change from time to time and may be governed by separate terms which apply specifically to the account. Where special account specific terms apply, you will be informed, and must accept those terms before you are given such an account. For the avoidance of doubt these Terms apply unless otherwise agreed or amended by account specific terms.
- 3. Some accounts may be governed by a separate Software Licencing Agreement with Healthii Hu,b which may amend the Terms of use. For the avoidance of doubt these Terms apply unless otherwise agreed or amended by the terms of an applicable Software Licence Agreement

ACCEPTABLE USE OF THE SERVICE.

DISPUTE RESOLUTION

Compulsory

Notice

A party to the Terms claiming a dispute ('Dispute') has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute

Resolution

On receipt of that notice ('Notice') by that other party, the parties to the Terms ("Parties') must:

- 1. within 30 days of the Notice endeavour, in good faith, to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;
- 2. if for any reason whatsoever, 30 days after the date of the Notic,e the Dispute has not been resolved, the Parties must request that an appropriate mediator be appointed by the Office of the Australian Information Commissioner
- 3. the Parties are equally liable for the fees and reasonable expenses of a mediator and the costs of the venue of the mediation and without limiting the foregoing undertake to pay any amount requested by the mediator as a pre-condition to the mediation commencing. The Parties must each pay their own costs associated with the mediation
- 4. the mediation will be held in Brisbane Queensland Australia

Confidentiality

All communications concerning negotiations made by the Parties arising out of and in connection with the dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiation for the purpose of applicable laws of evidence

Termination of Mediation



If 30 days have lapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either party may ask for the mediator to terminate the mediation and the mediator must do so.

VENUE AND JURISDICTION

The services offered by Healthii Hub is intended to be viewed by resident of Australia. In the event of any dispute arising out of or in relation to The Website, you agree that the exclusive venue for resolving any dispute Shelby in the courts of

SEVERANCE
